TUITION AND FINANCIAL INFORMATION

TUITION: The tuition for 2011-2012 is \$3800 for elementary students and \$3950 for middle school students. Tuition will be prorated for students who enroll after the school year begins.

APPLICATION FEE: The application fee is \$75 per child. This fee will be submitted with each application to Mintz Christian Academy. This fee covers the cost of processing an application. (Non-Refundable)

NEW STUDENT REGISTRATION FEE: The new student registration fee is \$175. This onetime fee, is submitted at the time of the interview, covers the cost of processing a new student including setting up records, screening, testing, orientation, interviewing, and billing. It will not exceed \$350 per family.

STUDENT RESOURCE FEE: The resource fee is \$325 per year (per child). This annual fee is due by June 1. It covers additional operational expenses that are not included in tuition, registration, or book fees. (Non-refundable)

WITHDRAWAL FEE: Students are considered enrolled for the entire school year. Therefore, budgets and teacher contracts are set accordingly. Early withdrawals create an opening MCA may not be able to fill. Therefore, students withdrawing will forfeit all fees paid. This fee is \$500.

PAYMENT OPTIONS:

Option A: Full Payment Plan. This plan offers a 5% discount if paid by August 1. If not paid by August 1, the discount is lost.

Option B: Monthly Payments. This plan is payable by bank draft.

Any accounts 45 days past due will result in a student's temporary suspension until the accounts are current. Records are not transferable to other schools for accounts that have past-due balances.

STATEMENT OF COOPERATION

SCHOOL ACTIVITIES: We give permission for our child(ren) to take part in any and all school activities, class field trips, including school-sponsored trips away from the school premises, and absolve the school from liability to us or our child(ren) because of any injury to us or our child(ren) at school or during any school activity. In the case of an emergency, we request that the school contact us first. If we are not available, please contact the designated emergency contact. If the emergency contact cannot be reached, the school has my permission to make whatever arrangements deemed necessary for our child(ren)'s treatment.

LATE PICKUPS: If parents are 15 minutes late in picking up students, the students will be signed into the after-school care center and should be picked up there. There will be a \$10.00 per hour charge for any part of the first or subsequent hours.

COMPUTER USER AGREEMENT (Grades K-8th)

REASONS FOR THIS POLICY: Mintz Christian Academy ("MCA") is providing computer network and Internet access for its students and employees. This service allows employees and students to share information, learn new concepts, and research diverse subjects.

MCA has adopted this Acceptable Use Policy ("Policy") to set guidelines for accessing the computer network or the Internet service provided by MCA. Every year, students desiring computer network and Internet access for that upcoming school year need to sign and submit a copy of the Policy to MCA. Parents or guardians must also sign this Policy. By signing this agreement, the student and parent or guardian agree to follow the rules set forth in this Policy and to report any misuse of the computer network or the Internet to a teacher or supervisor. Parties agreeing to this policy also understand that MCA may revise the Acceptable Use Policy, as it deems necessary. MCA will provide notice of any changes either by posting such a revised version of the Policy on its website or by providing written notice to the students and parents or guardians.

INTERNET USES: Use of the electronic information resources in the school shall be to improve and support the educational process by providing access to global information and improving communication between students, employees of MCA, parents, and community members.

ACCEPTABLE USES: All Internet or computer equipment use shall be consistent with the purposes and goals of MCA. It is imperative that users of the Internet or computer equipment conduct themselves in a responsible, ethical, moral, and polite manner. All users must abide by all local, state, and federal laws. The Internet user accepts the responsibility of adhering to high standards of conduct and the terms and condition set forth in all parts of this policy.

PRIVILEGE: The use of the Internet and computer equipment within MCA is a privilege. It is confidential information to the user unless it is transmitted to others with the user's permission. Violation of this policy can result in the loss of computer access privileges or further disciplinary action.

MONITORING: MCA reserves the right to monitor and review any material on any computer at any time in order for the school to determine any inappropriate use of computer resources.

DISCLAIMER OF ALL WARRANTIES: MCA makes no warranties of any kind, whether expressed or implied, for the services provided in connection with use of the Internet or computer equipment. Neither MCA nor any supporting Internet services will be responsible for any damages that an Internet user suffers. MCA expressly disclaims any liability in connection with the loss of data resulting from delays,

non-deliveries, failure to deliver, mistaken deliveries, viruses, backup device failure, service interruptions, or other unforeseen reasons caused by MCA or the Internet server or by the users error or omissions. Use of any information obtained via the Internet is at the user's own risk. MCA expressly denies any responsibility for the accuracy or quality of information obtained through any Internet service. All users must consider the source of any information they obtain and evaluate the validity of that information.

SECURITY: MCA will implement security procedures on Internet access to protect against unacceptable use. Computer users are responsible for the security of their files and passwords. Sharing of any usernames or passwords to anyone is not permissible and may result in the loss of account privileges. Computer users will be held accountable for any activity under their account. Any security problems should be reported immediately to the school/site administrator.

ENCOUNTER OF CONTROVERSIAL MATERIAL: Internet users may encounter controversial material which the user or administrator may consider inappropriate or offensive. The school has taken precautions to restrict access to inappropriate materials through a filtering and monitoring system. However, it is impossible on a global Internet to control access to all data that a user may discover. It is the user's responsibility not to initiate access to such material. Any site or material that is deemed controversial should be reported immediately to the appropriate administrator. MCA expressly disclaims any obligation to discover all violations of inappropriate Internet access.

TERMS OF USE:

1. Only registered students of MCA qualify for computer use under this policy.
2. Only the authorized users who have signed the user agreement shall have computer access. Users are ultimately responsible for all activity while using the Internet.
3. The Principal may suspend or terminate any computer user's access for any reason.
4. All Internet or computer equipment access of a student is automatically terminated at the moment of withdrawal, graduation, or expulsion of the student from MCA.

PENALTIES FOR IMPROPER USE: Any user violating this policy or applicable state and federal laws may be restricted from Internet use or use of any or all computers (in addition to other disciplinary options). Such additional options may include suspension, expulsion, and/or referral to legal authorities.

STUDENT: I understand and will abide by the Mintz Christian Academy Student Computer Acceptable Use Policy. I agree that I will keep my unique login and password information private and not allow others to have access using my account. **Should I commit any violation, I realize that my access privileges may be revoked and other disciplinary action may be taken** (which could include appropriate legal action).
